Executive Summary:

A Request for Bid (RFB) for the Additions and Renovation to Northwood Jr. High School Bid Release No. 1 was developed and publicly bid by Gilbane Building Company, as part of the Long Range Facility Planning Process. On April 18, 2019, the RFB specifications were released, and the bid notice was published in the Daily Herald on April 19, 2019. This Bid Release 1, is the enabling work for subsequent bid phases for the additions and renovations to Northwood Junior High School which will consist of a two-story classroom addition approximately 40,000 sf., Performing Arts addition approximately 8,800 sf., Dining/Cafeteria addition approximately 8,800 sf., and related site work. Renovation of existing Northwood Junior High School approximately 60,000 sf.

The Bid Release 1, contains the proposal of Building Demolition Work (02A). On May 10, 2019, five bids were received from U.S. Demolition LLC, Alpine Demolition Services, McDonagh Demolition, Milburn LLC, and National Wrecking Company (see attached bid tabulation). Based on the bids received for Bid Release 1, David Norris from Gilbane Building Company and Administration has identified National Wrecking Company as being the lowest responsible bidder and whose proposal complied with all of the requirements, see attached award letter from Gilbane Building Company.

Based on this information, Administration recommends that at the May 21, 2019 Board Meeting, the Board award the contract to National Wrecking Company for the Building Demolition Work of Bid Release 1, in the amount of \$349,300.00.
