Executive Summary:

A Request for Bids (RFB) for the renovation to Northwood Jr. High School Bid Release 5-12A Retractable Theater Seating was developed and publicly bid by Gilbane Building Company. On March 5, 2020, one (1) bid was received and opened from Carroll Seating, Inc. (see attached tabulation). Gilbane reviewed the bid and confirmed the lowest responsible and responsive bidder.
